



## PRIVACY POLICY

This privacy policy (“**Policy**”) describes how Delicious Origins LLC (“**Company**”) collects, uses and shares personal information of users registered on its website, [www.kitndo.com](http://www.kitndo.com) (the “**Site**”). We understand that providing information online involves a great deal of trust on your part. We take this trust very seriously and make it a high priority to ensure the security and confidentiality of your personal information you provide while creating your account. Before submitting this personal information to us, please read this Policy carefully to learn about our privacy practices. By using the Site, you are accepting the practices described herein.

### WHAT WE COLLECT

We get information about you in a range of ways.

- **Information you give us when you create an account on KITnDO.**  
We collect your full name, username, email address, postal address, preferred origin, picture, password, date of birth, demographic information (such as your gender, number of children and occupation) as well as other information you directly give us on our Site.
- **Information we get from others.**  
We may get information about you from other sources. We may add this to information we get from this Site.
- **Information Automatically Collected.**  
We automatically log information about you and your computer. For example, when visiting our Site, we log your computer operating system type, browser type, browser language, location, the website you visited before browsing to our Site, pages you viewed, how long you spent on a page, access times and information about your use of and actions on our Site.
- **Cookies.**  
We may log information using "cookies" to provide you with a more personal and interactive experience on our Site.

### USE OF PERSONAL INFORMATION

We use your personal information as follows:

- We use your personal information to operate, maintain, and improve our sites, products, and services.
- We use your personal information to process and deliver contest entries and rewards.
- We use your contacts information to process your invitations when you allow us to access your contacts from your computer, mobile devices or third party sites in aim to invite them to join the Site.
- We use your personal information to respond to comments and questions and provide customer service.
- We use your personal information to send information including confirmations, technical notices, updates, security alerts, and support and administrative messages.
- We use your personal information to communicate about promotions, upcoming events, and other news about products and services offered by us and our selected partners.
- We use your personal information to link or combine user information with other personal information.
- We use your personal information to protect, investigate, and deter against fraudulent, unauthorized, or illegal activity.
- We use your personal information to provide and deliver products and services customers request.

### SHARING OF PERSONAL INFORMATION

We may share personal information as follows:

- We publicly display your username, your picture and your city with country's initials as part of your account profile. If you believe that someone has created an unauthorized account depicting you or your likeness, you can request its removal by contacting us.
- We publicly display the information that you contribute through the Site intended for public consumption, such as reviews, photos, videos, comments, likes, bookmarks. We may share it with businesses and future distribute it to a wider audience through third party sites and services.
- We may share personal information with your consent. For example, you may let us share personal information with others for their own marketing uses. Those uses will be subject to their privacy policies.
- We may share personal information when we do a business deal, or negotiate a business deal, involving the sale or transfer of all or a part of our business or assets. These deals can include any merger, financing, acquisition, or bankruptcy transaction or proceeding.
- We may share personal information for legal, protection, and safety purposes.
  - We may share information to comply with laws.
  - We may share information to respond to lawful requests and legal processes.
  - We may share information to protect the rights and property of Delicious Origins LLC, our agents, customers, and others. This includes enforcing our agreements, policies, and terms of use.
  - We may share information in an emergency. This includes protecting the safety of our employees and agents, our customers, or any person.
- We may share information with those who need it to do work for us.

### **INFORMATION CHOICES AND CHANGES**

You can choose not to provide us with any information, although it may be needed to take advantage of certain features offered on our Site. You also can add or update information and close your KITnDO account as described below.

As a registered KITnDO member, you can modify your email subscription choice at any time on the Member Profile page. Whether registered as a KITnDO member or not, you also will be given the opportunity to unsubscribe from promotional messages in any such email we send. Please note that we reserve the right to send you other communications, including service announcements, administrative messages, and survey relating either to your account, without offering you the opportunity to opt out of receiving them.

Many browsers are set to accept cookies until you change your settings. However, the Help portion of the toolbar on most browsers will tell you how to prevent your browser from accepting new cookies, how to have the browser notify you when you receive a new cookie, or how to disable cookies altogether. Please note that if you remove or reject our cookies, it could affect how our Site works for you.

### **DATA RETENTION AND ACCOUNT TERMINATION**

You can close your account by contacting us. We will remove your public profile but we may retain information about you for the purpose authorized under this Privacy Policy unless prohibited by law. For example, we may retain information to prevent, investigate, or identify possible wrongdoing in connection with the Site or to comply with legal obligations. Also we retain contributions you made directly on our Site (added places, photos, reviews...). Please note that businesses cannot remove their business listings or reviews by closing their account.

### **CHILDREN**

The Site is intended to general audience and is not directed to children under 13. If you become aware that a child has provided us with personal information without parental consent, please, contact us. If we become aware that a child under 13 has provided us with personal information without parental consent, we take steps to remove such information and terminate the child's account.

### **SECURITY**

We recognize the importance of user's privacy and have taken the reasonable steps to protect your Data against loss, theft and unauthorized use, disclosure, or modification. However, no method of transmission over the Internet or via mobile device, or method of electronic storage, is 100% secure. Therefore, while we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security.
